- 5. Bonafide certificate of the student issued from the concerned institute.
- 6. Passport size photograph to be pasted on application forms duly attested by the Head of the Institution.
- 7. Fee receipt issued by the institute to be submitted in original.
- 8. Hostel Certificate (in case the applicant is a hostler) issued by the concerned institute.
- 9. The scholarship to the students studying in private institutions is admissible only in respect of institutions affiliated with the universities recognized by the central/State Govt. UGC/ State Board of Technical Education/Statury Professional Councils and attached documentary proof of recognition/ affiliation.
- 10. Attested copies of fee structure duly approved by Centre / State Government in case of private institutions.
- 11. Affidavit by the student as per specimen given in the application form.
