

1. The students from clas **1st primary to 12th** shall be covered under this scheme. and the scholarship shall be paid strictly as per the rates / %age of Marks required in the previous examination/Attendance/ guidelines contained in Govt. Order No.382-SWD of 2008 dated 29.12.2008.

2. Before disbursement of the scholarship, the list of eligible students/beneficiaries of Pahari Speaking Community prepared by the CEO/ZEO concerned will be authenticated by the **Tehsildar concerned** as per Govt vide Order No: 289-SWD of 2018 dated 19-11-2018 for the identification of Pahari Speaking students.
3. The payment of scholarship be made through DBT/EBT Mode only as per Circular issued by the Social Welfare Department Civil Secretariat vide No. SWD/Pig/308/2014-15 Dated 29-12-2014.
4. This release of funds based on calculation/requirement communicated from the office of the Chief Education officers in favour of those students whose information/detail complete in terms of exiting guidelines only.
5. No re-appropriation of funds be made without the approval of the competent authority.
6. That expenditure shall be made strictly as according to the classification under which funds have been authorized.
7. DDOs shall complete all the codal formalities before presentation of bills at the treasury.
