4. The payment of scholarship be made through **DBT Mode** only as per Circular issued by the Social Welfare Department Civil Secretariat vide No. SWD/PJg/308/2014-15 Dated 29-12-2014.
5. The beneficiaries will have to produce a fresh affidavit declaring there in that he/she belongs to Pahari Speaking Community and his/her parental income does not exceed to Rs 2.50 Lacs per annum and does not taking the benefit of another Schemes in the State and Centre.
6. A separate register indicating the names of the students with parentage residence, Constituency and amount transfer in the Individual A/C No. is maintained and copy of the same be submitted to this office.
