The expenditure shall be incurred subject to the following conditions:-

1. The students from 1st primary to 12th class shall be covered under this scheme. The scholarship to Pahari Speaking students from 1st primary to 12th class shall be paid strictly as per the rates/guidelines contained in Govt. Order No.382-SWD of 2008 dated 29.12.2008.
2. The identification of Pahari Speaking students shall be made strictly in consultation with the concerned State Advisory Pahari Board Members of the district nominated by the Govt vide Order No: 1373-GAD of 2010 dated 30-11-2010 or any other member/person authorized by this board.
3. The disbursement of the scholarship be made to the bonafide students at the institutional level through cheques only preferably in the presence of the Hon'ble MLA's/MLC's of the Pahari Speaking Community/Hon'ble State Advisory Board Members of the district.
4. The 1st and 2nd installment of scholarship should be disbursed in the month of September and March respectively through Cheques only strictly as per criteria laid down in Govt. Order No:382-SW of 2008 dated 29-12-2008.
5. No re-appropriation of funds be made without the approval of the competent authority.
6. A separate register indicating the names of the students with parentage, residence, amount paid by cheque, cheque No is maintained and one copy of the same be provided to this office as and when required for monitoring.
7. The short falls if any shall be immediately communicated to this office supported by Zone-wise details of students both boys and girls from 1st primary to 12th class for release of further funds accordingly.
- 8) The expenditure be incurred after observing all the codal formalities and shall be restricted to the allocations made
