On-line implementation will be done through State Portal under URL: <https://jk.gov.in/jkeservices>. Only online applications under these Schemes will be accepted and no request for offline applications will be entertained:-

INSTRUCRTIONS FOR AVAILING THE SCHOLARSHIP SERVICE:-

1. To avail the Scholarship, a candidate has to log to URL:- <https://jk.gov.in/jkeservices> and before applying the Service, User has to register himself using the Register Link given on the menu.
2. Applicant has to upload the scanned photo (jpg image) of size less than 20 kb before registration.
3. Please note the User ID and Password entered by the applicant during registration for Login and availing the service when needed.
4. Please select the role type Citizen while entering login credentials by the Applicant.
5. Please note the Citizen ID after successful registration as it will be required at the time of availing the service.
6. After login, applicant has to click on the e-services tab in the left menu, thereafter click on the Pahari Speaking Board and click on Post-matric scholarship.

The value of scholarship include maintenance allowance plus non-refundable fee compulsorily payable by the students.

The following documents in original shall be uploaded/attached with hard copy of the downloaded on-line application form:-



06. Income Certificate in original. Parents/Guardians current income certificate from all source from the concerned Tehsildar. (Income certificate with cutting/mutation will lead to rejection of Application forms.)

 - iv) All details mentioned in the form and documents attached are true and correct and nothing has been concealed therein.
 - v) I understand that in case I am found guilty of any wrong information for misleading the Government, the Government is liable to take any necessary action against me under rules, including recovery of the scholarship amount/being blacklist/debarred from any scholarship in the future.

Instructions related to bank Account Details (to be filled by the student in online application form are as under)

- i) Student must select their bank/branch name carefully from the drop down list.
- ii) Thereafter the account no. must be entered correctly. Students are suggested to get their account number verified by their concerned bank branch including Bank account number and IFS code.
- iii) **Disclaimer (if bank details entered by students are found incorrect or not validated by the student's bank, the scholarship will be cancelled /amount will not be transferred even though the application is approved for scholarship)**
- iv) Bank account holders must check their Know You Customer (KYC) status from bank and if required the KYC must be done for successfully transaction of scholarship amount.
- v) Bank Account must be operational /active till the scholarship is disbursed.
- vi) Bank Account must be in the name of either the student or a joint account of student with either mother or father or a legal guardian only.

THE GRANT OF SCHOLARSHIP IS SUBJECT TO THE FOLLOWING:-

Mere filling of on-line scholarship application form will construe no right on the student that he/she will be granted scholarship.

Scholarship will be restricted to availability of funds and also the merit and income.

The income limit prescribed is Rs. 2.50 lacs (maximum).

A Scholarship holder under this Schemes will not avail any other scholarship/stipend for pursuing the same course/class from any other Agency/Department.

The applicants are advised to take print-out of the duly filled-in application form, after submitting it on-line and submit the same to the concerned institution/College/University along with all requisite documents. The concerned Head of Govt. Institution/College/University will forward the on-line Applications with hard copies and forwarding online applications to State Advisory Board for development of Pahari Speaking People and maintain record of students who have applied for scholarship for further reference when required by the State Advisory Board for development of Pahari Speaking People .
